



### **Holy Trinity Catholic School Countdown to Summer Raffle Rules:**

1. Entries may be purchased via cash or check. Credit card purchases are not permitted under Indiana Charity Gaming Laws.
2. Entrants must be 18 years of age or older.
3. Each entry will be entered separately in the drawing. Each entry is a separate and equal chance to win the \$2,500 prize. Odds are dependent on the number of entries sold.
4. In the case that less than 4,000 entries have been sold, this raffle will revert to a 50/50 raffle with the maximum prize of \$1,000 awarded.
5. The winner will be asked to sign an affidavit that he/she complies with the minimum age requirements and that the winner purchased the winning entry via an approved purchase method.
6. Entrants to this raffle do so of their own initiative and are responsible for compliance with the entrant's own state and local laws.
7. Winner need not be present at the time of the drawing to win.
8. This raffle is a fundraising effort of Holy Trinity Catholic School, an Indiana nonprofit corporation designated by the Internal Revenue Service as meeting the qualifications of Section 501(c)(3) of the Internal Revenue Code, as amended. Holy Trinity Catholic School is located in Jasper, Indiana and this raffle is being conducted under the laws of the State of Indiana. All proceeds will support programs at Holy Trinity Catholic School.
9. The winner is responsible for all local, state and federal taxes following the date of the drawing. The winner understands, acknowledges, and agrees that he/she is receiving a prize and will hereby release and discharge Holy Trinity Catholic School, and any additional sponsors, their employees, agents, officers, directors, and legal representatives and assigns from any and all claims, liabilities, damages, losses or expenses arising from or caused by the award of such prize, including, but not limited to the payment of any and all taxes that are due.
10. The Internal Revenue Service (IRS) has taken the position that amounts paid for chances in raffles, lotteries, or similar drawings for valuable prizes are not gifts and consequently do not qualify as deductible charitable contributions.
11. The winner will be announced at the official drawing to be held on May 26th, 2021 at Precious Blood Church, 1385 W. 6<sup>th</sup> Street in Jasper, Indiana 47546. Due to COVID-19, the drawing will not be a public event.
12. If the winner is not present, he/she will be notified via phone, certified mail or email within 7 days of the drawing. The prize must be claimed within 30 days of the drawing.

To claim the prize, the winner will be required to sign and deliver to Holy Trinity Catholic School: (a) a sworn affidavit of eligibility in accordance with these Rules and applicable law, including without limitation that he or she is at least 18 years old at the time he or she purchased an entry into the raffle: (b) such written information as is required by any applicable tax laws, including without limitation his or her Social Security Number: and (c) two forms of identification, one of which must



be a photo ID showing that the person claiming the prize is the same person who is named on the winning raffle entry.

16. All entry sales will end at 3:30 pm EST on Friday, April 30th, 2021.
